SUBJECT: CR-53 – Creation of the Homelessness Community Task Force

PURPOSE

To formally create the Homelessness Community Task Force.

BACKGROUND

On October 28, 2019, City Council approved Resolution No. 19-115 adopting the 2019-2023 Strategic Plan. Homelessness is an action step under Strategic Priority #5-2. Strategic Priority #5 is Housing Opportunities. The goal definition for this priority is: Curate the diversity of housing stock for all ages, socioeconomic demographics and family types, and increase investment in housing repairs and renovations.

City Council provided staff with direction at the November 4, 2019 study session to move forward with the creation of a Homelessness Community Task Force. The Council Strategic Plan calls for organizing a community Task Force in Q1 of 2020 (see page 18 of the Strategic Plan). The following program outline was presented to City Council for review on January 27, 2020.

Northglenn Homelessness Community Task Force Purpose

The Task Force will be charged with development of key recommendations that will be presented to the City Council following completion of the Task Force work. The Task Force is envisioned as an advisory group to the City Council.

The overall purpose of the Task Force is envisioned as follows:

- To develop recommendations to be presented to City Council
- To be action-oriented and assist the City with implementation of recommendations
- Identify who makes up Northglenn's homeless population (families, individuals, etc.)
- Identify the services the City could provide (beyond today) in partnership with other service providers. Does the City need to hire a Homelessness Navigator as other cities are doing?
- Identify where a possible increase in level of service is possible
- How to connect individuals and families experiencing homelessness with services and service providers (going beyond providing phone numbers)
- How the City can leverage existing services and build partnerships with service providers not currently established
- Identify short-term challenges and possible solutions
- Identify long-term challenges and possible solutions
- Identify and recommend how the City can expand educational efforts and awareness of the issues and challenges surrounding homelessness

Staff will provide support to the Task Force in providing informational presentations as requested on current City services and requests for information from other service providers.

UPDATE

Following City Council direction at the January 27, 2020 meeting, the Task Force membership application was made available online and email invitations were sent to multiple service providers. The City also promoted the opportunity to get involved on social media. As of February 20, 2020, 29 applications have been received and the deadline for applications is Friday, February 21, 2020. The applications include a good mix of service providers and residents interested in serving on the Task Force. Staff will contact applicants the week of February 24 to schedule the first meeting of the Task Force for the week of March 2 or March 9. The focus of the first meeting will include the following four key foundational elements to set the Task Force up for success:

Meeting #1

- Introductory remarks by City Manager/review of logistics and purpose.
- Introductions and sharing by Task Force members about why they are choosing to serve.
- Overview of steps the City has taken to date by the City Manager.
- A facilitated discussion of what additional information Task Force members would like to have to help them with their work.

Meeting #2

- Selection of a Task Force Chair to facilitate the meetings and work with staff liaisons to move the work of the Task Force forward.
- The second piece of the second meeting will be designed based off of feedback and input from Task Force members at the first meeting.

STAFF RECOMMENDATION

Staff recommends approval of CR-53.

BUDGET/TIME IMPLICATIONS

The City will provide any necessary supplies to the Task Force, which are not anticipated to exceed \$250 to \$500. Staff will bring back a funding request to Council if there are significant funds needed beyond administrative costs. As shared on January 27, the overall goal is to have recommendations identified so that any budget items can be considered as part of the 2021 City budget process.
