SUBJECT: CR-56 – Setting Public Hearing on CB-1942

PURPOSE

To set a public hearing on CB-1942 – Amendment to the City Code Adding a Human Resources Department for the special City Council meeting on March 9, 2020.

BACKGROUND

Section 3-1-4(d) of the Municipal Code states the following regarding the procedure for the adoption of ordinances:

"Once approved on first reading, it shall be posted in full pursuant to resolution of Council unless otherwise provided herein. Council shall hold a public hearing on the ordinance at the next regular meeting unless a different date for such hearing is set by resolution. Notice of the day, hour, and place of the public hearing shall be included in the first posting."

Although March 9, 2020 is the second Monday of the month and would typically be considered a regular City Council meeting, the meeting has been scheduled to convene at 6:00 p.m., which differs from the regular meeting start time of 7:00 p.m. and is considered a special meeting. CB-1942 will also be scheduled for second reading at that meeting on March 9.

STAFF RECOMMENDATION

Attached to this memorandum is a resolution which, if approved, would set the public hearing on CB-1942 for March 9, 2020 at 6:00 p.m. Staff recommends approval of CR-56.

BUDGET/TIME IMPLICATIONS

Conducting the public hearing on March 9 will allow Council to consider the adoption of the ordinance at the same meeting. If adopted, CB-1942 will be published as required by the City Charter, and will take effect five days after publication.
