PURPOSE

The purpose of this report is to provide updates for Q/4 2019 and a year-end overview on economic development projects and activities. A presentation of the information is included as Attachment 1.

NEW DEVELOPMENTS COMING SOON

Co-Working Space Coming to Northglenn

Office Evolution, the largest co-working franchisor in the U.S. will open a new 11,300-squarefoot facility in the Metro North office building at 11990 Grant St., Suite 550. They will offer solutions for entrepreneurs and small businesses with offices and shared and virtual workspaces. This will include 45 private offices, two conference rooms, drop-in options, phoneanswering, address and mail services, and other professional amenities. They are currently working on tenant improvements and plan to open this spring.

112th Avenue & Huron Street Redevelopment

Two commercial land sites are planned for redevelopment at 112th Avenue & Huron Street. NNN Huron 112 LLC is developing 1.97 acres of vacant land located north of the BBVA bank for a new 3,060-square-foot 7-11 convenience store with six fuel pumps and an independent car wash. Additionally, the BBVA bank lot to the south is concurrently redeveloping their site and will demo its existing facility and construct a smaller bank building. There will be an additional one-acre site for future development opportunities.

Karl's Farm

Centre Communities plans to develop 63.8 acres of vacant land at 120th Avenue & York Street. This will be a master-planned mixed-use development. Three residential developers (Southern Land, Richmond, and Meritage) are in the entitlement process for a variety of new housing opportunities.

Marketplace Redevelopment owners, Hutensky Capital Partners, invested \$2 million in the tenant finish to relocate the existing Bed Bath & Beyond store to make room for construction of a new

Civic Center

Construction is underway for the new 87,887 square-foot recreation center, senior center and performing arts The Northglenn Urban theatre. Renewal Authority (NURA) bonded \$11 million for public infrastructure improvements for the Civic Center project. The trunk infrastructure and detention pond construction will help opportunities on the remaining 11.4 development. acres of land. This investment by

NURA takes advantage of utilizing Tax Increment Financing (TIF) for a longer period of time, low bond rates, and strong market conditions for future private sector development. A Request for Qualifications was released in February to seek a master developer for the remaining private sector land.


Delta by Marriott

An \$18 million interior and exterior renovation to the existing Ramada Plaza Hotel is planned. Once complete this will be a Delta by Marriott full-service hotel, with a Starbucks and Tony Roma's restaurant.

Annual 2019 Project Highlights

- Bed Bath & Beyond relocated its existing store to the 25,100-square-foot former Borders building on the east side of the Marketplace in late October 2019.
- Boondocks located at 11425 Community Center Drive invested more than \$1.5 million in its facility. Interior improvements included a fullservice restaurant, bar, kitchen, private event space, bowling alley and, other major interior enhancements.
- The Courts completed construction of its \$4.8 purple million, 31,500-square-foot, multi-purpose sports complex located at 112th Ave. & Washington St. and opened in January 2020.
- Scooters Coffee broke ground on a 557-square-foot drive-thru coffee shop at 11461 Washington St. and invested \$538,000. They completed construction and opened in February 2020.




Annual 2019 Housing Statistics

At the end of December, the average median list price for a single-family Northglenn home was \$365K vs. \$348K last year at this time.




Annual 2019 Sales Tax

Annual 2019 New Business Announcements

At the end of December 2019, Northglenn reported a total of 968 businesses. Of that total, 752 were storefronts and 216 were home-based businesses. This resulted in 78 new storefronts and 44 home-based businesses, which added 275 storefront and 53 home-based jobs. Storefront businesses absorbed 141,951 square feet of office, retail and industrial space. There were 55 businesses that closed, which made the 2019 net new businesses 23. 








