A BILL FOR AN ORDINANCE AMENDING SECTION 14-3-8 OF THE NORTHGLENN MUNICIPAL CODE TO PROHIBIT HORSES ON PUBLICLY OWNED OR MAINTAINED PROPERTY

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTHGLENN, COLORADO, THAT:

Section 1. Section 14-3-8 of the Northglenn Municipal Code is amended by the addition thereto of a new subsection (h) to read as follows:

(h) It shall be unlawful for any person to permit or allow an unconfined horse on publicly owned or maintained property unless such person has received written permission from the City Manager in the form of a permit or license for a special event or parade. For purposes of this subsection (h), publicly owned or maintained property shall mean and include any public street, way, place, alley, sidewalk, trail, path, easement, park, open space area, square, median, parkway, boulevard, plaza, building, structure or other property that is dedicated to public use.
