SUBJECT:	CR-55 - Parks and Recreation Advisory Board Staggered Term Adjustment (Revised)

**RECOMMENDATION:** Attached to this memorandum is a Resolution, which, if approved, would adjust the current Ward II term on the Parks and Recreation Advisory Board from 3 years to 2 years. This action has been recommended by the Parks and Recreation Advisory Board, as well as staff, and would stagger the terms of each of the board positions, eliminating the likelihood that all of the positions on the board would be vacated within the same year.

**BACKGROUND:** In 2007, a recommendation was made by the City Attorney and staff that the terms for board positions on the Parks and Recreation Advisory Board be adjusted to re-establish staggered terms. On May 24, 2007, CR-40 was adopted by Council. CR-40 made adjustments to currently filled positions, as well as one open position in Ward II. Provisions within CR-40 indicated that this open position was to be filled for a 2 year term, rather than the standard 3 year term, in order to re-establish the appropriate staggering of terms.

On July 26, 2007, CR-70 erroneously appointed Brian Swinbank to the vacant Ward II position for a 3 year term, rather than the two year term that was decided upon with CR-40.

Mr. Swinbank has indicated his interest in being reappointed for a new 3 year term when his current term expires, a request for action which will be brought forward to Council in July of this year.

**BUDGET/TIME IMPLICATIONS:** There are no anticipated budgetary impacts that will result from any action taken regarding staggered terms for the Parks and Recreation Advisory Board. It is recommended that this action be taken prior to the new expiration date of Mr. Swinbank's term in July of this year.
