

A BILL FOR AN ORDINANCE AMENDING SECTION 7-1-6 OF THE NORTHGLENN MUNICIPAL CODE BY THE ADDITION OF A NEW SUBSECTION (k.5) REGARDING PEDESTRIAN OBLIGATIONS TO ADHERE TO TRAFFIC CONTROL SIGNALS


BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTHGLENN, COLORADO, THAT:

Section 1. Section 7-1-6 of the Northglenn Municipal Code is amended by the addition thereto of a new subsection (k.5) to read as follows:

(k.5) Section 802(3) is hereby amended as follows:

(3) No pedestrian OR PERSON RIDING A BICYCLE OR OTHERWISE USING A CROSSWALK NOT AFOOT shall suddenly leave a curb or other place of safety and walk, or run, OR OTHERWISE ENTER into the path of a moving vehicle which is so close as to constitute an immediate hazard. WHEN TRAFFIC SIGNALS ARE IN PLACE AT A MARKED CROSSWALK, A PEDESTRIAN OR PERSON RIDING A BICYCLE OR OTHERWISE USING A CROSSWALK NOT AFOOT SHALL EXERCISE REASONABLE CARE, WHICH SHALL INCLUDE, BUT NOT BE LIMITED TO, ACTIVATION OF ANY TRAFFIC CONTROL SIGNALS PRIOR TO USING THE CROSSWALK.
