SUBJECT: Acceptance of Dick's Sporting Goods Sponsorship CR-147

RECOMMENDATION: Staff recommends that Council approve the attached Resolution accepting a sponsorship check in the amount of \$2,000 to purchases a new scoreboard for the recreation center gymnasium.

BACKGROUND: The current scoreboard in the recreation center gymnasium is approximately 19 years old and is in dire need to be replaced due to electrical shorts within the scoreboard. Dick's Sporting Goods has given the City of Northglenn a \$2,000 donation to be able to purchase a new scoreboard for the gymnasium. The scoreboard will display the Dick's Sporting Goods logo. The new scoreboard will be lit by LED lights which are more energy efficient and require less ongoing maintenance than the past generation scoreboard which is currently installed in the gymnasium.

BUDGET/TIME IMPLICATIONS: The cost for shipping and handling of the scoreboard is \$2,295, plus \$541.76 for shipping and handling. The sponsorship will be deposited as revenue to offset the majority of the expense, with the remaining \$836.71 to be paid from the existing Parks, Recreation & Cultural Services 2009 budget. There are adequate funds to cover this expense in the 2009 budget.
