

A BILL FOR AN ORDINANCE AMENDING SECTION 8-1-4, SUBSECTION (a) TO CONFORM WITH AMENDMENTS TO THE CITY OF NORTHGLENN HOME RULE CHARTER AS APPROVED BY THE REGISTERED ELECTORS OF THE CITY OF NORTHGLENN


BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTHGLENN, COLORADO, THAT:

Section 1. Section 8-1-4, subsection (a) of the City of Northglenn Municipal Code is amended to read as follows:

Section 8-1-4. Municipal Judges--Appointment--Removal.

(a) The municipal court shall be presided over by, and its functions exercised, by a municipal judge who shall be a licensed member of the Bar of this State in good standing, who shall be appointed by the City Council of the City of Northglenn for a term of UP TO two years


