A BILL FOR A SPECIAL ORDINANCE AMENDING THE 2009 BUDGET RECOGNIZING REVENUES AND APPROPRIATING EXPENDITURES BY SUPPLEMENTAL APPROPRIATION, FOR THE PAYMENT OF THE COSTS AND EXPENSES OF THE MUNICIPAL GOVERNMENT, AGENCIES AND OFFICES OF THE CITY OF NORTHGLENN, COLORADO, FOR THE FISCAL YEAR BEGINNING JANUARY 1, 2009

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTHGLENN, COLORADO, THAT THE 2009 BUDGET SHALL BE AMENDED AS FOLLOWS:

- Section 1. Supplemental appropriations, transfer of appropriations and recognition of revenues.
 - (a) <u>General Fund.</u> Amend the 2009 General Fund budget to increase estimated revenues in the amount of \$73,572, as follows:

\$73,572 from the United States Department of Justice, Justice Assistance Grant (JAG) awarded July 10, 2009 for the purpose of replacing communication devices and other equipment within the Police Department.

Recognize an increase in 2009 General Fund unrestricted fund balance in the amount of \$73,572 represented by the above description.

(b) General Fund. Amend the 2009 General Fund budget to increase appropriations in the amount of \$73,572, as follows:

\$73,572 for the purpose of funding the replacement of communication devices and other equipment within the Police Department.

Recognize a decrease in 2009 General Fund unrestricted fund balance in the amount of \$73,572 represented by the above expenditure estimates.

- Section 2. The City Council of the City of Northglenn, Colorado, hereby finds and declares that in making appropriations provided by this ordinance:
 - (a) No appropriation for debt service has been reduced or transferred.
 - (b) No appropriation has been reduced below any amount required by law to be appropriated.
 - (c) No appropriation has been reduced by more than the unencumbered balance thereof.

(d)	In the case of each transfer of all or part of any unencumbered appropriation, suc transfer has been requested and approved by the City Manager.
