SUBJECT:	CR-103, 2009 - Larson Park Improvements

BACKGROUND:

The existing chain link fence on the west side of Larson Park was installed in the 1970's. This fence has deteriorated over time and the existing opening in the fence on the west side of the park near the Y-Mart has served as an undesirable access point between the businesses on Washington St. and the neighborhood surrounding Larson Park. The Larson Park Improvements project will replace 380 feet of the existing fence with a steel fence and install a new fence section that will close the existing access point on the west side of the park. The new fence will be aesthetically pleasing, vandal resistant, and a clear delineation between Larson Park and the adjacent businesses.

On August 27, 2009, the City accepted five (5) bids for the Larson Park Improvements Project. The lowest responsible bidder is Greater Western Fence & Supply, Inc. with a bid of \$44,902.20. City staff contacted the submitted references and determined the Contractor's past performance on similar projects meets the City's standards. Results of the reference checks were positive and are on file at City Hall. Copies of the standard agreement and bid tabulation are attached. Staff is requesting a 25% contingency to address concrete repairs that may be required when attaching the new fence to the existing retaining wall behind Y-Mart.

BUDGET/TIME IMPLICATIONS:

The cost of the Larson Park Improvement Project as proposed is \$44,902.20 plus contingency of \$11,226.00 for a total of \$56,128.20. Adequate funding for the project in the amount of \$149,025.00 is available from the Capital Projects Fund (Account No. 210.69235.000.3999.421)

RECOMMENDATION:

- Authorize the Mayor to execute a contract between the City of Northglenn and Greater Western Fence & Supply, Inc. for the Larson Park Improvement Project in the amount of \$44,902.20;
- 2) Authorize \$11,226.00 as a contingency and authorize the City Manager, on behalf of the City, to approve minor changes in the scope of work and execute relevant change orders up to the approved expenditure limit of \$56,128.20.

Total expenditures for this project will not exceed \$56,128.20. Staff recommends approval of the proposed Resolution.

6. The CITY will pay to the CONTRACTOR in the manner and at such times as set forth in the General Conditions such amounts as required by the CONTRACT DOCUMENTS.
