Action Item:

Reconsideration by Motion of CR-60/Res. 09-56 regarding Sewer Rates and Charges Increase

Council member Wieneke spoke about the utility rates adopted by CR-60, and stated that the wastewater rates and a monthly sewer service charge had not been discussed as part of the rate increases. Council member Wieneke stated that he would like to revisit the sewer rates before implementing the rate increase and new monthly service charge.

There was discussion about delaying the implementation of the monthly service charge for wastewater and reconsidering the sewer

rates. There was discussion about eliminating the monthly service charge and the process for reconsidering the adopted rates and charges.

Mr. David Willett, Public Works Director, provided information about the monthly service charge and the total net revenue increase targeted by the utility rate study to meet capital outlay.

#### MOTION TO PASS

Council member Paiz **MOVED** and it was **SECONDED** by Council member Monroe to reconsider CR-60/Res. 09-56 regarding sewer rates and charges increase and to delay the implementation of new sewer rates and the monthly wastewater service charge until reviewed at the July 16, 2009 study session, with an implementation date of August 1, 2009.

#### **DISCUSSION ITEMS:**

Sales Tax

Council member Baker spoke about the utility rate study and stated that he feels the consultant was charged with producing rates that would eliminate two one-half percent sales taxes and the food tax. Council member Baker spoke about the revenue generated by the water rates and the collection of taxes used for the water system.

City Manager Simmons spoke about the two one-half percent sales taxes that are set to expire on December 31, 2010 and the food tax. There was discussion about not including taxes in a long range plan because of the need for approval by the voters to continue the taxes. There was also discussion about the use of the taxes for water rights acquisition and for the costs associated with producing the water, and the need to plan for maintenance of the water system. It was the consensus of Council to review the sales taxes at the study session on July 16, 2009.

### COMMUNICATIONS COUNCIL

Council member Parsons reported on the unveiling of sculptures for the Art on Parade program and thanked those that attended the event. Council member Parsons announced that voting for the People's Choice sculpture is now open and noted that voting can be done online at <a href="www.northglennarts.org">www.northglennarts.org</a>. Council member Parsons reported that the *Open Space* sculpture would be gifted to the City and installed at the Northwest Open Space on Thursday, July 2, 2009.

Council member Monroe stated that spirit nights for the Youth Commission would be held at local restaurants in the next few weeks

to raise funds for the skate park project. Council member Monroe thanked the residents who attended the recent Ward II Meeting and extended get-well wishes to the officer involved in the accident today and to Judge Cohen.

Mayor Pro Tem Paiz asked staff to remind the public that the City will be hosting the Fourth of July Celebration this year and to provide an overview of the event.

Ms. Jenni Murphy provided information about the Fourth of July Celebration. Ms. Murphy stated that events begin at 7:00 a.m. in the morning and continue throughout the day ending with fireworks at approximately 9:30 p.m.

Council member Clyne reported on the Finance Committee meeting. She stated the Committee had reviewed the monthly financial statements and spoke about the revisions made to the format of the report. Council member Clyne reported that the Committee also discussed the status of the audit and the implementation of the financial management system.

Council member Baker stated the City should discourage water contact in Webster Lake unless the City is aware of the bacteria present.

Ms. Amanda Peterson, Parks, Recreation and Cultural Services Director, reported that it is posted that swimming and wading in Webster Lake is prohibited.

City Manager Simmons provided additional information about the response to the citizen inquiry regarding retaining wall standards. City Manager Simmons also spoke about the officer-involved accident this morning and thanked the entities involved in the investigation of the accident.

Mr. Jim Hayes, Planning and Development Director, provided an economic development update. Mr. Hayes spoke about existing and new businesses in the City, businesses along the 104<sup>th</sup> Avenue corridor and in the Marketplace, the 104<sup>th</sup> Avenue Bridge Replacement project, and the 120<sup>th</sup> Avenue Development project. It was the consensus of Council to receive monthly economic development updates.

Police Chief Russ VanHouten reported that a meeting would be held on Monday, June 29, 2009 at 7:00 p.m. to discuss crime in the Webster Lake Townhomes neighborhood.

City Manager Simmons spoke about the 2009 Budget. City Manager Simmons spoke about staffing levels and stated organizational changes and business practices are currently being reviewed to manage revenues to expenditures and to improve productivity.

## PUBLIC INVITED TO BE HEARD

Mayor Pro Tem Paiz invited any member of the public wishing to speak on any subject to come forward.

Dr. Sean Reif, Ward I, expressed concern about Council's reduced meeting schedule, and stated he would like town hall meetings to be held to allow citizens to discuss issues. Dr. Reif also spoke about government spending, local leadership and community policing. Dr. Reif also spoke about ways to conserve fuel, energy efficiency and recycling materials.
