Ms. Bonnie Bell, 11762 Grant Street, distributed a copy of a property appraisal report that misidentified 11762 Community Center Drive as 11762 Grant Street. Ms. Bell stated she has had issues with getting an appraisal of her property and receiving deliveries because of the street alignment and feels that adding the street name to the address markers at the Recreation Center and City Hall would help to identify

Community Center Drive.

Mr. Jason Maxey, United Power, spoke about the annual process of allocating the company's capital credits back to its members based on electrical usage, and presented the City with a check for its capital

credit refund.

Mr. Bob Montoya spoke about a sewer line issue at his property on Carrol Lane. Mr. Montoya stated the Mayor and City Manager had helped him resolve the issue, but expressed concern with the sewer line insurance company and the service they provided.
