#### PRESENTATIONS:

Economic Development Update

Ms. Debbie Tuttle, Economic Development Manager, provided an update on the Business Appreciation Breakfast, the Shop Small Business event on November 30<sup>th</sup>, and a Shop Northglenn campaign. Ms. Tuttle reported on the Count the Lights program, the Mile High Signs billboard, and the SafeBuilt scholarship program for Northglenn High School seniors. Ms. Tuttle spoke about responses to the Webster Lake Plaza survey and provided information on new businesses, ribbon cutting events, and upcoming groundbreaking events.

Ms. Tuttle addressed questions about the scholarship program and vacancy rates.

#### Transportation Update

Mr. Brook Svoboda, Director of Planning and Development, provided an update on the Colorado Department of Transportation (CDOT) I-25 Managed Lanes Project and spoke about the project schedule and proposed noise wall along the Stone Mountain and City of Northglenn property line. Mr. Svoboda spoke about the Regional Transportation District (RTD) North Metro Rail Line project and provided information about the RFP selection process and intergovernmental agreement for the project.

Mr. Svoboda addressed questions about the transportation projects. Council requested to receive a summary on the timeline and placement of the fencing for the I-25 Managed Lanes project.

#### FINANCIAL REPORT:

September 2013 Update

Mr. Jason Loveland, Director of Finance, provided a financial report for the period ending September 30, 2013. Mr. Loveland spoke about revenue and expenditures for the General Fund, Water and Wastewater Fund, Stormwater Fund, Sanitation Fund, Conservation Trust Fund, and Capital Projects Fund.

Mr. Loveland addressed questions about General Fund revenue, use tax collected in specific months, and revenue collection in the Stormwater and Sanitation Funds.
