Ms. Joslyn Martinez, Colorado Public Interest Research Group (CoPIRG), spoke about a report CoPIRG recently released on transportation and current driving trends. Ms. Martinez stated the report indicates a decline in the average number of miles driven by Americans and a desire for better public transportation options among younger drivers. Ms. Martinez spoke about national forecasts that may overestimate an increased need for transportation, which could lead to wasteful investments, and offered to meet with Council to discuss the report further.

Acting City Manager Willett reviewed agenda items for upcoming meetings. It was the consensus of Council to cancel the July 15th study session and to schedule the School Zone Safety Assessment and Regulation of Adult Use/Retail Marijuana items for the August 5th study session.

There was discussion about addressing the School Zone Safety Assessment prior to the start of the new school year to allow time for improvements to be made.

City Attorney Hoffmann reported the State had issued emergency rules for the retail sale of marijuana on July 1st, and stated he is reviewing the rules in preparation for the August 5th study session. City Attorney Hoffmann reported on a meeting he attended earlier today with other municipalities regarding the banner issue with Xcel Energy and stated they are working to resolve the issues.
