Council member Whitman thanked staff for their work on the Noel Northglenn event. Council member Whitman acknowledged the Northglenn High School STEM Program for earning a national certification for its Project Lead the Way program and congratulated the School.

Council member Carrico reported on the Adams 12 Five Star Schools Board of Education meeting. Council member Carrico provided information about charter schools and the District's efforts to possibly lower their mill levy for residents. Council member Carrico also reported she attended the Olde Fashioned Christmas event at the Stonehocker Farmhouse and Noel Northglenn at the Recreation Center.

Mayor Downing stated Noel Northglenn was outstanding and recognized staff for their work on the event. Mayor Downing announced there is a need for volunteers for the bike repair program and asked anyone interested to contact Ms. Jenni Murphy.

Council member W. Dodge reported there are twelve days left to participate in the Count the Lights contest and encouraged everyone to visit the local businesses that are participating in the program.

Council member Mullica reported he attended Noel Northglenn and stated it was a great event. Council member Mullica reported on his orientation with staff and stated he had attended a meeting at the Colorado Municipal League.

Council member Snetzinger reported she received positive email messages from residents about Noel Northglenn. Council member Snetzinger recognized the Police Department for their No Shave November project and stated the Department had raised \$4,100. There was discussion about the No Shave November project and Chief May stated he would participate next year by shaving his head in place of growing a beard. Council member Snetzinger also reported on the KYGO Christmas Crusade and the Police Department's participation in the program.

City Manager Pick thanked Council for their comments about Noel Northglenn and stated he would pass them on to staff. City Manager Pick stated two upcoming study sessions fall on Martin Luther King, Jr. Day and Presidents' Day and stated the meetings would be canceled due to the observance of the holidays.
