

A BILL FOR AN ORDINANCE AMENDING SECTION 9-13-4 OF THE NORTHGLENN MUNICIPAL CODE


BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTHGLENN, COLORADO, THAT:

Section 1. Section 9-13-4(b)(10) of the Northglenn Municipal Code is amended to read as follows:

(10) Live Bands and music. No person shall play, practice, or perform, or permit to be played, practiced, or performed, any live music audible at a residential real property boundary, between the hours of 10 p.m. and 7 a.m. Live bands and music playing within allowed hours under this subsection (b)(10) shall not be deemed a noise disturbance within the meaning of this Section 9-13-4.


