Dear Steve:

On behalf of the Northglenn Arts & Humanities Foundation, I would like to request that the following location be presented to City Council for the permanent installation of the sculpture, *Open Space* by George Manus. We anticipate the installation to take place in the latter weeks of August, with a dedication within the first weeks of September (pending the artist's availability).

Proposed location: Northwest Open Space - Ward 4

The NAHF is requesting placement on the island in the roundabout, accessed by the north entrance, at the Northwest Open Space. The NAHF believes this location site is conducive to sculpture placement and will directly enhance the physical environment within the park setting. Additionally, the sculpture will be highly visible from multiple sight lines with-in the park.

Site preparation: Some of the low-growing brush at that site would need to be relocated or cut down. Potential redirection of sprinkler heads within the planter bed may be needed. A platform would be built to sit directly in the middle of island and elevated for maximum viewing from all sides.

Secondary location: If Council does not approve the recommended location, the NAHF has determined that the Fox Run Open Space would also be a desirable location for *Open Space*. The piece would be installed at the entrance of the open space, directly off of Fox Run Parkway. If this location is approved I will need to get HOA approval from the Fox Run neighborhood.

Following approval by the Northglenn City Council, I will need to present the proposed location to the Adams County SCFD Commission for approval, as well.

On behalf of the Northglenn Arts & Humanities Foundation (NAHF), I would like to request that the following location be presented to City Council for the permanent installation of the sculpture, *Imagine That* by Kathy Anderson. We anticipate the installation to take place in the latter weeks of August, with a dedication within the first weeks of September (pending the artist's availability).

Proposed location: Wyco Park (Ward 2)

The NAHF is requesting placement near the park sign at the Wyco Park on Wyco Drive. The NAHF believes this location site is conducive to sculpture placement because of the theme of a young girl reading and playing soccer in relationship to the environment of being adjacent to two schools and a soccer field. Additionally, the sculpture will have good visibility from Wyco Road and by all students and parents using the surrounding schools and neighborhood.

Site preparation: A platform would be built to sit in relationship to the side walk and covered area near the park sign, and elevated for maximum viewing from all sides.

Secondary location: If Council does not approve the recommended location, the NAHF has determined that Sperry Park would also be a desirable location for *Imagine That*. The piece would be installed near the bench by the playground.

Following approval by the Northglenn City Council, I will need to present the proposed location to the Adams County SCFD Commission for approval, as well.
