FINANCIAL REPORT:

Update

Ms. Acqunetta Likkel, Acting Finance Director, provided a financial update for the period ending August 31, 2008. Ms. Likkel spoke about revenue and expenditures for the General Fund, Water and Wastewater Fund, Stormwater Fund, and Sanitation Fund. Ms. Likkel reported on fines and forfeitures, sales and use tax revenue, charges for services, and debt service revenue.

Ms. SuzAnne Garcia, Treasury Manager, provided an update on the City's investment portfolio, issues relating to the City's investments in the Colorado Surplus Asset Fund Trust (CSAFE), and the financial management system project.

There were questions from Council about the status of the bank reconciliation, and the placement of the investments that were drawn from the CSAFE program.

Huron Center Conditions Study

Mayor Novak opened the public hearing and invited anyone wishing to speak either "for" or "against" the Huron Center Conditions Study to come forward.

Mr. Pat Breitenstein, Acting Executive Director of the Northglenn Urban Renewal Authority (NURA), provided information about the area that was considered in the Huron Center Conditions Study and asked that a copy of the report be entered into the record. Mr. Breitenstein provided an overview of the study, the process used to communicate with residents and business owners in the area, and the proposed addition to the urban renewal plan. Mr. Breitenstein stated that the study concluded that nine of the eleven criteria regarding blight were found to be present in the Huron Center area.

Ms. Jackie Brutout, Vice President of Panorama Property Management, stated that the owner of the property her company manages in the Huron Center did not receive notice of the public hearing. Ms. Brutout spoke about the ownership of the four parcels of property in the Huron Center and stated that she cannot make improvements to the Albertson's building because of its separate ownership. Ms. Brutout submitted a letter from one owner, Mr. Richard Kolsch, for the record, and stated that she is opposed to the area being blighted.

Ms. Myrna Glimm stated that she lives and works in the Huron Center area, and stated that she feels the deterioration in the Huron Center is minor. Ms. Glimm stated that she believes blighting the area would negatively affect the neighborhood and property values and would discourage other businesses from coming in to the area.

Mr. Dallas Briggs, Ward I, stated that the trail project on the north side of 104th Avenue was supposed to improve the area near the Huron Center. Mr. Briggs stated that he feels blighting this area would be unfortunate for the residents, and stated that he feels the condition of the Center is a result of the code department failing to take action on an area in need of assistance.

Mr. Lupe Flores stated that he feels the Huron Center area looks deteriorated and inquired about the possibility of blighting a portion of the area.

COMMUNICATIONS

COUNCIL

Council member Wieneke spoke about the agenda format and suggested moving discussion items to occur prior to Council communications. It was the consensus of Council to revise the next meeting agenda to reflect this change.

Council member Downing reported that a Ward II meeting would be held on Monday, October 13, 2008 at 6:30 p.m.

Mayor Novak reported that she had attended the ribbon cutting event for the North Metro Fire Rescue District's new training facility. Mayor Novak inquired about sending a donation to the American Cancer Society in memory of former Police Chief C.A. Gunderson. There was discussion and it was the consensus of Council to coordinate efforts with the Police Department to recognize Mr. Gunderson. Mayor Novak reported that the Fire District would be hosting the only Colorado stop of the pink fire truck to raise funds for breast cancer awareness at 1:00 p.m. on Saturday, October 11th.

Council member Paiz reminded everyone that a reception to meet the City Manager candidates would be held on Friday, October 10th from 5:00 p.m. to 6:30 p.m. at the Ramada Plaza, and also noted that the candidates would be interviewed by Council on Saturday, October 11th at 9:00 a.m. in Council Chambers. Council member Paiz inquired about Council's desire to take a position on Amendment 52 with the Denver Regional Council of Governments (DRCOG). There was discussion and it was the consensus of Council to remain neutral on the issue.

Council member Monroe reported that she would like to invite the Adams County Assessor to speak to Council about foreclosures and property assessments. Council member Monroe reported that Crossroads Church would be hosting four families that are political refugees from Burma and noted they would be residing in Ward IV. Council member Monroe also reported that she had attended the opening event for the North Metro Fire Rescue District's training facility and spoke about the facility's features.

Acting City Manager Allen thanked Council for the opportunity to serve in the manager capacity, and also thanked staff for their assistance during his service.

<u>DISCUSSION ITEMS:</u> 104th Avenue Bridge

Mayor Novak provided information about the study session that was held prior to the Council meeting with NURA.

Council member Wieneke spoke about recent case law and the issue of taking action on items that are added to the agenda.

City Attorney Hoffmann provided information about the open meetings law and Council's ability to take action on urgent items.

There was discussion about the 104th Avenue Bridge project and the conversation that took place earlier during the study session with NURA regarding funding for the project.

City Funding for 104th Avenue Bridge MOTION TO PASS

Comprehensive Plan Process

Council member Wieneke spoke about the comprehensive plan process and suggested that staff present the existing comprehensive plan to the public when soliciting input on changes to the plan.

Ms. Sonja DiCarlo, Planning Commission Chairman, stated that the City does not have an existing comprehensive plan. Ms. DiCarlo spoke about the different neighborhood plans in place and the Commission's desire to have one comprehensive document. Ms. DiCarlo also spoke about the process that would be used to gather information from the public.

There was discussion about the separate comprehensive plan documents that exist, the land use map, and the Commission's plans to solicit public input.

Mr. Jim Hayes, Planning and Development Director, provided information on the comprehensive plan process. Mr. Hayes reported on the initial comprehensive plan meeting and spoke about the elements that are missing from the current collection of neighborhood plans. Mr. Hayes also spoke about the information that would be presented at the upcoming workshops.

Acting City Manager Allen spoke about presenting the current district plans to the public and highlighting the deficiencies of those plans. Acting City Manager Allen also spoke about the areas that are commonly affected when comprehensive plans are updated.

Croke Reservoir Opening

Acting City Manager Allen reported on the Croke Reservoir project and provided information on the completion of the project. He stated that an opening ceremony for the reservoir had been postponed due to budget restrictions and the extended completion date. Acting City Manager Allen asked Council for direction regarding the scheduling of an opening ceremony for the project.

There was discussion about the project and Council's desire to have an opening event for the community. It was the consensus of Council to schedule an opening ceremony for Croke Reservoir to be held when the project is complete.

PUBLIC INVITED TO BE HEARD

Mayor Novak invited any member of the public wishing to speak on any subject to come forward.

Mr. Russ VanHouten reminded everyone about the Northglenn Thornton Rotary Club's shred-a-thon event this Saturday from 10:00 a.m. to 1:00 p.m. at the southeast corner of 104^{th} Avenue and Colorado Boulevard. Mr. VanHouten provided information on the cost for shredding documents and encouraged everyone to attend the event.
