#### **RECOMMENDATION:**

Attached to this memorandum is a Resolution which, if approved would authorize the Mayor to execute a contract between the City of Northglenn and Landmark Landscapes, LLC (Landmark) for the 2008 Citywide Fence Maintenance Project in the amount of \$217,614.70 and authorize a contingency in the amount of \$21,761.47. Staff recommends approval of the proposed resolution.

#### **BACKGROUND:**

In a continuing effort to improve and maintain the City's infrastructure, Staff has identified a need to clean and treat approximately 25,265 linear feet of arterial fence within the City of Northglenn as shown on the attached map. On April 21, 2008, the City accepted two (2) formal bids. The low bid contractor is Colorado Designscapes, Inc.(Designscapes) with a bid of \$87,919.26. Landmark's bid was \$217,614.70. After reviewing the bids, Staff determined that the chemical cleaning proposed by Landmark would be more effective than the simple power wash proposed by Designscapes. Landmark also bid a double application of a superior finish as opposed to the single application of a more inferior product proposed by Designscapes which would not be as durable or long-lasting.

## **POTENTIAL OBJECTION:**


City Staff is not aware of any specific opposition to the proposed Resolution.

#### **BUDGET/TIME IMPLICATIONS:**

The budget as proposed for the Landmark Landscapes, LLC contract is \$217,614.70 with a contingency in the amount of \$21,761.47 for a total of \$239,376.17. Funds in the amount of \$150,000 are available in the Conservation Trust Fund (Account No. 210.69237.000.3999.540). Funds in the amount of \$100,000 are available in the General Fund (Account No. 410.69237.000.3999.540).

- 4. The CONTRACTOR agrees to perform all of the WORK described in the CONTRACT DOCUMENTS and comply with the terms therein for the sum of \$217,614.70, or as shown in the attached proposal. The CONTRACTOR will commence the work within 7 calendar days after the date of NOTICE TO PROCEED. The CONTRACTOR will complete the work within 60 calendar days after the date of NOTICE TO PROCEED unless the period for completion is extended otherwise by the CONTRACT DOCUMENTS.
- 5. The term "CONTRACT DOCUMENTS" means and includes all items as set forth in Section 1.01 of the General Conditions.
- 6. The CITY will pay to the CONTRACTOR in the manner and at such times as set forth in the General Conditions such amounts as required by the CONTRACT DOCUMENTS.
- 7. This AGREEMENT shall be binding upon all parties hereto and their respective heirs, executors, administrators, successors, and assigns.
