Northglenn Receives Large Community of the Year Award from EDCC

The City was honored by the Economic Development Council of Colorado (EDCC) at their spring conference as the 2013 Large Community of the Year. Members of Council and staff were honored to receive this award at the EDCC Awards Luncheon on Thursday, May 1. This award is presented to a community over 20,000 in population that demonstrates support for economic development through an organized program and strong leadership. Northglenn was chosen based on its creative, innovative, and strategic business attraction, retention and expansion efforts, as well as for fostering new capital investment, new jobs, special projects and outreach efforts. Some of the projects that were completed or broke ground in 2013 included:

Smart Commute Metro North

The economic development staff is working with Smart Commute Metro North (SCMN) to outreach to Northglenn businesses to educate them and their employees on commuting opportunities and mobility options. SCMN provides information to help commuters expand their transportation choices, especially as construction on I-25 ramps up. The following are some of the commuting opportunities that are available for residents and employees:

- Vanpool approximately 50% off the normal leasing rate = \$450/mo. or \$75-90/person/mo
- Transit Free 10-pass ticket books available during "ozone season" (May-September)
- Use "CDOT Mobile" commuter app for real-time traffic alerts
