# **Caliber Collision Coming to Northglenn**

Cross Development has purchased the 30,780 square foot former Northglenn Dodge Collision Center located at 650 W. 106th Avenue. Cross Development is a Texas-based development company that represents Caliber Collision Centers, which will be the tenants of the building. Caliber is expanding into the Denver metro market and has chosen Northglenn for one of their new locations.

Caliber has approximately 167 facilities and serves over 260,000 people across the nation. It is the largest collision repair company in America with centers in Arizona, California, Colorado, Nevada, New Mexico, and Oklahoma.

Cross Development will be making approximately \$800,000 in capital investments to the exterior and interior of the building. The improvements include complete interior office renovation, new roof, building foundation repairs and minor shop improvements. They are also constructing a new storefront at the main (north) entry, a new covered parking awning, handicapped parking spaces and improvements, and partial asphalt parking lot resurfacing with a complete reseal of the parking lot. The Northglenn Urban Renewal Authority (NURA) approved a Business Improvement Grant for \$12,500 to assist in the exterior improvements on this project.

They plan to start construction in August, with a grand opening planned for January, 2015. Caliber Collision will initially employ 15-20 technicians and 8-10 office staff. For more information, visit www.calibercollision.com.

A Request for Proposal will be developed to solicit proposals to evaluate redevelopment opportunities and potential end-users for the building and lot.

# ICSC - ReCon Convention

Staff attended the annual ICSC ReCon convention in Las Vegas. This is a global convention for the retail shopping center industry and provides networking, deal making and educational opportunities. They had over 32,000 attendees and 1,000 exhibitors. Staff met with many brokers, developers and potential endusers to discuss retail opportunities in Northglenn.

# **Adams County Connects**

The third annual regional *Adams County Connects* event is being held on Thursday, June 26 from 2 PM to 6 PM, at Woolley's Classic Suites in the Gateway Business Center, located at 16450 E. 40th Circle in Aurora. Economic development agencies from across Adams County are collaborating on this event, which will combine a tradeshow-like atmosphere with educational and resource providers, and networking opportunities for primary employers.

### **New Business Announcements**

At the end of May, Northglenn had a total of **871** businesses. Of that total, **666** are storefronts businesses and **205** are home-based occupations. This year, Northglenn has announced **34** new storefront businesses, which have added **487** new jobs and absorbed **119,145** square feet of office, industrial and retail space. *Note: Caliber Collision will be added to the totals when their business license is submitted.*
