COMMUNICATIONS:

Council Council member Whitman reported she participated in the roundtable

discussion with the Youth Commission and stated she attended the Water Treatment Facility tour. Council member Whitman reported on

the Business Appreciation Breakfast and thanked everyone who participated in Safe Street Halloween.

Council member Carrico thanked the Police Department, staff, and Northglenn High School students for the Safe Street Halloween event and thanked the North Metro Fire Rescue District for the free mammogram screenings. Council member Carrico announced that School District 12 had received a nationwide award for innovation.

Mayor Pro Tem C. Dodge reported on the Northglenn Arts & Humanities Foundation and grant funding received from the Scientific Cultural Facilities District and Colorado Creative Industries for theatre and arts programs. Mayor Pro Tem C. Dodge reported on the Youth Commission and the roundtable they hosted with City Council, and reported she attended Safe Street Halloween. Mayor Pro Tem C. Dodge announced the Northglenn Senior Organization will be hosting a Senior Halloween Party on Friday, October 31st at 1:00 p.m.

Mayor Downing reported on Safe Street Halloween and stated she attended the Water Treatment Facility tour. Mayor Downing reported she attended the grant presentation for the Northglenn Arts & Humanities Foundation and also participated in the Arvada Mayor's roundtable event.

Council member Brown spoke about Safe Street Halloween and stated it was a great event.

Council member Snetzinger announced she and Council member Wieneke will be hosting a Ward 4 meeting on Wednesday, November 5th and stated the meeting will include information on parks and recreation, the 2015 budget, and general updates.

City Clerk Small provided information about the upcoming election on November 4th and encouraged voters to utilize the new 24-hour ballot drop-off in front of City Hall. City Clerk Small reported she participated in Safe Street Halloween to obtain input about the City and stated it was a great event.

PUBLIC INVITED TO BE HEARD

Mayor Downing invited any member of the public wishing to speak on items previously addressed by Council to come forward.

Mr. Matt Dudley expressed concern about marijuana businesses in the City of Northglenn and stated he feels the marijuana business approved for the location near Northglenn High School creates a danger for students who walk by the business. Mr. Dudley spoke

about statistics regarding marijuana use and inquired about the approval of the license for the business.

Ms. Lisa Dudley spoke about marijuana businesses in Northglenn and expressed concern about the shopping center near Northglenn High School. Ms. Dudley stated she feels the marijuana business will have a negative effect on property values and parents' decisions to enroll their children in Northglenn High School.

Ms. Sara Farris, North Metro Fire Rescue District, reported on the free mammogram screenings and announced a winter clothing and winter coat drive for A Precious Child would be held from November 10th through December 8th.

Mr. Colby Dillon, Northglenn Police Officer, spoke about the second annual No Shave November fundraiser to benefit the American Cancer Society and invited Council to attend the "shave-off" event at the end of the fundraiser on December 1st at 9:30 a.m. at Floyd's Barber Shop.

Mr. Matthew Cisneros spoke about marijuana businesses and stated he feels allowing the businesses will provide minors with easier access to marijuana. Mr. Cisneros stated he feels the businesses will attract crime to the area and expressed concern about the City approving a marijuana business near Northglenn High School.

There was discussion about the public hearings that have been held on marijuana licenses, the lack of public input and attendance by the public at the meetings, and notice provided to the public.

Mr. Caleb Dudley stated he is a Northglenn High School student and spoke about the shopping center which includes a liquor store and a marijuana business. Mr. Dudley spoke about minors obtaining alcohol and marijuana and inquired about procedures to prevent minors from obtaining marijuana.
