SUBJECT:	Council Resolution $CP-19$ Review of Contract Addendum #2 – City Hall Administration Needs Assessment and MEP Evaluation

#### BACKGROUND

On February 10, 2014 Northglenn City Council awarded a contract to Architects Design Group (ADG) for the Police Facility Needs Assessment in the amount of 58,274.00. The scope of work in the original contract included:

Phase One – Needs assessment (Police service) Phase Two – Conceptual Design (Police Service) Phase Three – Vacated Space Planning

On April 25, 2014 the City Manager approved contract addendum #1 to adjust the scope of services of the original contract with no price adjustment. The scope of work for the contract addendum included:

Phase Four – Needs Assessment, additional scope (include – Municipal Court) Phase Four – Conceptual Design, additional scope (include – Municipal Court) Phase Three – Vacated Space Planning (removed from the scope of work)

At the study session dated June 2, 2014 it was requested by City Council to negotiate additional scope and cost to include a needs assessment of the current City Hall administration. The additional scope of services for the City Hall Needs Assessment includes:

Phase Five – Needs Assessment City Hall Administration Phase Six – City Hall Facility – Mechanical, Electrical, Plumbing (MEP) Assessment Phase Seven – City Hall Facility – Energy Analysis and Cost Projections

#### **BUDGET/TIME IMPLICATIONS**

Budget Encumbered by Resolution (CR-14)	
Architects Design Services Contract	\$58,274.00
Contingency	\$00.00

The original architectural and design project appropriations did not include a contingency because the magnitude associated with the conceptual planning exercise did not warrant one. Due to the City's requested changes in scope to include an overall assessment of City Hall the consultant is requesting a contract addendum in the amount of \$32,200.00.

Pending Council's approval, the revised professional services contract would be **\$90,474.00** (\$85,274 + 32,200).

#### **<u>RECITALS</u>**:

A. On February 10, 2014 the City and Consultant entered into an Agreement for Professional Services for architectural engineering services (the "Agreement").

B. The parties desire to supplement the Agreement with this Addendum #2 to allow for an additional scope of services for the design services for:

#### **EXHIBIT A, ADDITIONAL SCOPE OF SERVICES**

#### **AGREEMENT**

NOW, THEREFORE, it is hereby agreed that for the consideration hereinafter set forth, that Consultant shall provide to the City, professional engineering services as needed in the manner provided in the Agreement.

1. The Scope of Services in the Agreement is hereby supplemented to include the scope of services for the design services attached hereto as **Exhibit A**, and incorporated herein by this reference (the "Additional Scope of Services"). Consultant shall commence work on the Additional Scope of Services within ten (10) days of the issuance of a Notice to Proceed.

2. Subparagraph A. of Article IV entitled "Compensation" is hereby amended to provide as follows:

A. Compensation shall not exceed \$32,200.00 for the work described in **Exhibit A** to this Addendum #2.

3. The original Agreement is in full force and effect and is hereby ratified by the City and the Consultant. The original Agreement and this Addendum constitute all of the agreements between the City and the Consultant.

## **EXHIBIT A – ADDITIONAL SCOPE OF SERVICES**

# V. PHASE FIVE – NEEDS ASSESSMENT CITY HALL EXCLUDING POLICE AND MUNICIPAL COURT

The needs assessment shall include, but not limited to the following:

- A. Utilizing plans provided by the City of Northglenn, provide an objective evaluation of existing City Hall space.
- B. Conduct a series of interviews with City Hall representatives to discuss current and future staffing projections and confirm organizational structure. Additional progress meetings with city staff shall be considered outside of the interviews.
- C. Verify, and update current Northglenn City Hall space requirements leading to a right-sizing of the space requirements.
- D. A total space needs assessment shall be rendered for both current and future projections.
- E. Adjacency requirements graphically represented based on interview feedback. Adjacencies should include detailed internal division adjacencies, overall building adjacencies and site adjacencies.

## VI. PHASE SIX – CITY HALL FACILITY MEP ASSESSMENT

The needs assessment shall include, but not limited to the following:

- A. Due Diligence Review the existing building Mechanical, Electrical, and Plumbing (MEP) systems to assess their condition and feasibility for complete replacement. This will include discussion with facility personnel, and a visual site evaluation of the existing building systems with review of original building drawings as required in order to claridy system capacities or service areas.
- B. Comparison Analysis Evaluate the options of rebuilding the existing building MEP system as opposed to the construction of a new facility using current engineering practices in projecting the types of systems and overall operation that might be a part of each option.
- C. Energy Analysis Perform a limited energy analysis of the existing building focusing on the exterior building envelope, including walls, windows, roof and insulation values. LEED and/or Green Ratings System analysis is not included.
- D. ROM (Reasonable Order of Magnitude) Cost Opinion Provide "order of magnitude" cost opinion for MEP system based on generally accepted pricing criteria (RS Means Construction Cost Data).

E. Above scope of work is to include not more than two (2) site visits, review meetings, or other scheduled on-site activities.

# VII. PHASE SEVEN – CITY HALL FACILITY ENERGY ANALYSIS AND COST PROJECTIONS

The needs assessment shall include, but not limited to the following:

- A. Energy Analysis Assist with architectural items relation to building component energy analysis such as replacement windows, new insulation, ect. Verify code requirements. Create specifications for these energy related building items.
- B. ROM (Reasonable Order of Magnitude) Cost Opinion Provide and verify cost opinion for building envelope components required by code based on industry cost pricing criteria (RS Means Cost Data).
