


BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTHGLENN, COLORADO, THAT:

A BILL FOR A SPECIAL ORDINANCE REPEALING ORDINANCE NO. 1508, SERIES OF 2008

WHEREAS, on February 28, 2008, the City Council finally adopted Ordinance No. 1508, Series of 2008, which stated an intent by the then City Council to not make the existing Recreation Center property available for development;

WHEREAS, the City Council also as of February 2008 determined that it was the intention of the City Council to repair the current Recreation Center; and


WHEREAS, the current City Council desires to show more flexibility regarding future development, and the possibility of including the Recreation Center in such future development plans.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTHGLENN, COLORADO, THAT:

Section 1. Ordinance No. 1508, Series of 2008 is hereby repealed in its entirety.

Section 2. Any future sale of the Recreation Center property shall be approved by the City Council by special ordinance, which shall require a public hearing.


