


**SUBJECT:** CR – 51, 2010 Wastewater Treatment Plant Bio-solids Removal, Hauling, and Disposal

**BACKGROUND**

In accordance with the City's Wastewater Treatment Plant (WWTP) discharge permit, issued by the Colorado Department of Public Health and Environment (CDPHE), the City is prohibited from permanently storing bio-solids on-site. As part of the normal operations of the WWTP, approximately 600 tons of bio-solids are produced annually which accumulate in the lagoon system. Biological activity breaks down the organic matter resulting in a nutrient rich material suitable for beneficial uses such as fertilizer and soil conditioner. The bio-solids are dredged from the lagoons for commercial use by state regulated contractors. A portion of the bio-solids that are removed from the WWTP lagoons are applied to the agricultural area located at the WWTP. Last year the City harvested wheat on the property. Corn has also been grown.

In February 2008, the City solicited bids for the removal of the bio-solids. Two contractors responded to the City's request and Liquid Waste Management (LWM) was determined to be the lowest qualified bidder. Attached to this memorandum is the formal bid summary. The Agreement was structured so that pricing was based on tonnage. The Agreement also required both on-site application in association with the agricultural activities, and off-site hauling and disposal. The agreement included a one (1) year fixed price contract, and extension mutually agreed upon for each of the next two years. The annual price increase for the successive years would be equal to the Denver-Boulder Consumer Price Index. Recent Index data from the second half of 2008 through the first half of 2009 shows a decrease of 0.6%. The pricing for calendar 2010 reflects the 0.6% decrease.

The original agreement with LWM was approved by City Council on March 13, 2008, Resolution Number 08-45 (attached). The first one year extension was approved by City Council February 12, 2009, Resolution Number 09-21 (attached).

The City accomplished the following activities during calendar 2009:

- Removed 838 tons of bio-solids
  - 457 tons were applied to Contactor's sites and 381 tons to the agricultural area owned by the City.
- Harvested 2564 bushels of wheat, generating \$1500 of revenue.

The City realized a cost savings of approximately \$50,000 on its 2009 bio-solids removal contract by applying the bio-solids to our agricultural property as opposed to hauling it off site.

**BUDGET/TIME IMPLICATIONS**

The cost of Wastewater Treatment Plant bio-solids removal, hauling, and disposal as proposed is \$ 215,000. Adequate funding for this service is available from the 2010 Water & Wastewater Fund/Wastewater Operations Division /Technical Services.

The following is submitted for your consideration regarding price adjustment for the 2010 Contract for Biosolids Removal and Disposal. Liquid Waste Management (LWM) is proposing changes based on the following:

1. The most recent available information on the U.S. Department of Labor website shows for the Consumer Price Index for the Denver-Boulder-Greeley urban area as follows: mid-year 2009: **207.444**; mid-year 2008: **208.741** (Data for year-end 2009 is not available yet.) The **decrease** in the CPI index for this area for the one-year period from 2008-2009 is **0.62%**. Source:

As such, LWM proposes the following pricing for 2010 Biosolids Removal & Disposal activities. This pricing represents a **decrease** of 0.62% over 2009 pricing for biosolids removal and dredging services. 2010 pricing for biosolids removal would be as follows:



**SUBJECT:** CR-48 – 2008 Wastewater Treatment Facility Bio-solids Removal, Hauling, and Disposal

**RECOMMENDATION:**

Attached to this memorandum is a Resolution which, if approved, would authorize the Mayor to execute an Agreement between the City of Northglenn and Liquid Waste Management, Inc. (LWM) to provide Bio-solids Removal, Hauling, and Disposal services during the 2008 calendar year for an amount not to exceed \$180,000. Staff recommends approval of the proposed Resolution.

**BACKGROUND:**

In accordance with the City's Wastewater Treatment Facility (WWTF) discharge permit issued by the Colorado Department of Public Health and Environment, the City is prohibited from permanently storing bio-solids on-site. As part of the normal operations of the WWTF, the City generates approximately 600 dry tons of bio-solids annually. Lagoon Cell 3 East is used to stabilize the bio-solids before they are removed and applied for beneficial use as a fertilizer and soil conditioner pursuant to State and Federal regulations.

The City accomplished the following activities during 2007:

- Permitted the City-owned land adjacent to the WWTF for bio-solids application.
- Removed approximately 470 wet tons of grit from Lagoon Cells 1 and 2 East, and Cells 1 and 2 West.
- Removed over 1,500 dry tons of bio-solids from Lagoon Cells 3 East and West.

By permitting the City-owned lands for bio-solids application, the City was able to avoid the costs of hauling the bio-solids to an off-site location. This allowed the City to remove a greater quantity of bio-solids than was originally planned. As a result, the City realized a cost savings of approximately \$115,000 on its 2007 bio-solids removal program.

To minimize operating costs during 2008, the City is planning to apply bio-solids on the City-owned property adjacent to the WWTF again. However, for this practice to be effective, the City will need to grow crops to consume the elevated nutrient levels which result from last year's application. The contract documents for 2008 were revised accordingly to include provisions for the contractor to grow and harvest crops on the City-owned property. The estimated savings to the City would be approximately \$176,000, assuming all of the bio-solids removed during 2008 can be applied on-site instead of hauling it to an off-site location.

During the course of operating the WWTF for the past 25 years, the City has gradually accumulated between 6,000 and 9,000 tons of bio-solids. This estimate was derived from the following information:

- For the first 10 years of operation (1982 to 1991), no historical records of bio-solids removal are available on-site, except during 1987 when approximately 250 tons were removed.
- In 1992, the City began removing bio-solids on an annual basis. This practice continued through 2002 and the average amount removed during this timeframe was 352 tons per year.

- No bio-solids were removed in 2003, 2004, and 2005.
- Approximately 340 and 1,560 tons were removed in 2006 and 2007, respectively.

City staff intends to spread out the removal of the accumulated bio-solids over the next 8 to 10 years. This approach will allow the City to systematically remove the excess accumulation while keeping up with ongoing bio-solids generation.

The City plans to remove approximately 1,400 dry tons of bio-solids during the late summer or fall of 2008. Of this total, most if not all of the bio-solids, will be removed from Lagoon Cell 3 East. If Lagoon Cell 3 East cleaning is completed in 2008 without exceeding the 1,400 dry ton goal, the remaining difference will be removed from Lagoon Cell 3 West that still has accumulated bio-solids but is no longer in service.

The Agreement is structured in a manner so that unit price bids were required for both on-site application with associated farming activities and off-site hauling and disposal. Two contractors responded to the City's request for bids and LWM was determined to be the lowest qualified bidder. Since LWM satisfactorily provided the same type of services to the City during 2007, reference checks were not necessary.

Finally, the contract documents include a provision for the City to renew the agreement for two, one year extensions. The maximum allowable increase of unit costs for each extension will be limited by the percentage change in the Denver/Boulder Consumer Price Index or by an adjustment that is mutually agreed to by both parties. Any future extensions of this Agreement will be presented to City Council in the form of a resolution for consideration and approval.

**POTENTIAL OBJECTION:**

Other than a temporary increase in odors that may occur during the removal of bio-solids, City Staff is not aware of any specific opposition to the proposed Agreement.

**BUDGET/TIME IMPLICATIONS:**

There is no impact to the General Fund. The not to exceed cost of the Agreement during 2008 is \$180,000.00. There are sufficient funds in the 2008 Utilities Department Operating Budget (account number 510.65104.000.3199) to pay for the bio-solids removal services.


