A BILL FOR AN ORDINANCE AMENDING SECTIONS 2-2-4 AND 2-2-10 TO CONFORM WITH AMENDMENTS TO THE CITY OF NORTHGLENN HOME RULE CHARTER AS APPROVED BY THE REGISTERED ELECTORS OF THE CITY OF NORTHGLENN

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTHGLENN, COLORADO, THAT:

Section 1. Section 2-2-4 of the City of Northglenn Municipal Code is amended to read as follows:

Section 2-2-4. ~~Councilmen~~ COUNCIL MEMBERS.

(a) Two (2) ~~councilmen~~ COUNCIL MEMBERS shall be elected from each of the four (4) wards of the City, AND SHALL SERVE STAGGERED TERMS AS SET FORTH IN THE CITY OF NORTHGLENN HOME RULE CHARTER. ~~At the November 5, 1985, regular election the candidate in each ward receiving the highest number of votes shall be elected for a four (4) year term and the candidate receiving the next highest number of votes shall be elected for a two (2) year term. At the next subsequent EACH regular election and at each regular election thereafter, one councilman~~ COUNCIL MEMBER from each ward shall be elected to serve a four (4) year term.

(b) Elected officials shall assume office at the first regular meeting of City Council held ~~in January next following the election~~ FOLLOWING CERTIFICATION OF ELECTION RESULTS.

(c) Each ~~councilman~~ COUNCIL MEMBER when nominated and elected shall be a citizen of the United States, a qualified elector of the City, shall have resided in the City for a minimum of one year immediately preceding such election, and shall have resided in the ward from which nominated for a minimum of thirty-two (32) days.

Section 2. Section 2-2-10 of the City of Northglenn Municipal Code is amended to read as follows:

Section 2-2-10. Election and Tenure. Every officer at a general municipal election shall take office at the first regular meeting of City Council ~~held in January at or next following such election~~ FOLLOWING CERTIFICATION OF ELECTION RESULTS, and shall hold such office until his successor is duly qualified
