


A BILL FOR AN ORDINANCE AMENDING SUBSECTION 8-2-3(c) OF THE CITY OF NORTHGLENN MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTHGLENN, COLORADO, THAT:

Section 1. Section 8-2-3(c) of the City of Northglenn Municipal Code is hereby amended by the addition of a new subsection (9) to read as follows:

(9) Four dollars and twenty-five cents (\$4.25) -- upon the entry of a judgment utilizing the Alternative Sentencing Program.
