A BILL FOR AN ORDINANCE AMENDING SECTION 8-2-4(a)(2) REGARDING THE TIME TO REQUEST A JURY TRIAL

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTHGLENN, COLORADO, THAT:

<u>Section 1</u>. Section 8-2-4(a) of the Northglenn Municipal Code is hereby amended to read as follows:

(a) <u>Trial by Jury</u>. A defendant shall be entitled to a jury trial if:

(1) The defendant is charged with an offense for which Section 16-10-101, Colorado Revised Statutes, AS AMENDED 1973 (as amended July 1, 1988) preserves the right to a jury trial, and if

(2) Within-ten (10) TWENTY (20) days after arraignment or entry of a plea, the defendant files with the municipal court a written jury demand and at the same time tenders a jury fee of \$25.00, unless the jury fee is waived by the judge because of the indigence of the defendant.

(3) No child under the age of eighteen years shall be entitled to a trial by jury for a violation under the Northglenn Municipal Code.
