### **DISCUSSION ITEMS:**

City Council Salary Increase

Council member Snetzinger spoke about the automatic ten percent (10%) increase to the Council honorarium every four years that was approved in 1995 and is scheduled to occur in January 2012. Council member Snetzinger stated she is opposed to the increase in pay due to the recent salary freeze for employees.

City Attorney Hoffmann provided information about the automatic pay increase for City Council which commenced in 1998 and is set to occur every four years. City Attorney Hoffmann stated the seated Council is unable to either increase or decrease its pay and spoke about alternatives to receiving the automatic increase.

There was discussion about reducing the percentage of the pay increase or matching the percentage to the amount of salary increase received by City staff. There was discussion and Council directed the City Attorney to prepare information on the options available to Council. There was discussion about the monthly stipend Council receives and whether the amounts should be adjusted. Council members Snetzinger, Whitman, and C. Dodge volunteered to serve on a subcommittee to review the stipend.

#### **COMMUNICATIONS:**

Council

Council member C. Dodge reported that she had attended Noel Northglenn and stated it was a very nice event. Council member Dodge reported that she had also attended the Christmas event at the Stonehocker Farmhouse and wished everyone a happy holiday.

Council member Carrico reported on the North Metro Fire Rescue District's fire-based emergency medical services, the number of calls

they have received, and the District's new audio and visual alerting system.

Mayor Pro Tem Clyne complimented staff on the Noel Northglenn event. Mayor Pro Tem Clyne reported that the Finance Committee had discussed revising the City's Investment Policy to address issues related to the type of investments that may be purchased and stated the Committee would bring the Policy forward after the State Legislature has acted on the issue.

Mayor Downing stated Noel Northglenn was a successful event. Mayor Downing reported that she had attended an Urban Drainage and Flood Control District meeting and noted that staff from the District had been chosen to serve on the National Emergency Preparedness Board.

Council member Whitman reported that she had attended the Noel Northglenn event and encouraged everyone to participate in the Count the Lights contest. Council member Whitman inquired about the giving tree in City Hall and wished everyone a Merry Christmas.

Council member W. Dodge reported on the Count the Lights contest and noted the contest would be ending this Saturday. Council member Dodge reported that he had attended a legislative breakfast at the Chamber of Commerce and stated the Chamber's legislative priorities for 2012 are: transportation, education, workforce development, energy, and economic development.

Council member Snetzinger reported that the Police Department is accepting donations for the Christmas Crusade for Children program through December 19<sup>th</sup> and stated the gifts would be wrapped on December 21<sup>st</sup>. Council member Snetzinger recognized Oriana Noble, a 6<sup>th</sup> grade student at Northglenn Middle School, who had received an award from the University of Colorado's Winning Attitude Contest, and reported on the recent Citizens Academy graduation and Teen Academy graduation. Council member Snetzinger reported on the Northglenn Urban Renewal Authority (NURA) meeting and stated the first two Business Incentive Grant applications had been approved by the Board.

City Manager Simmons reported that the Transportation Investment Generating Economic Recovery (TIGER) Grant application submitted by the North Area Transportation Alliance (NATA) for a managed lanes project on I-25 had not been selected for funding. City Manager Simmons spoke about issues relating to municipal inmates housed at the Adams County Detention Facility and reviewed agenda

City Attorney Hoffmann reported he would be providing a litigation update to Council prior to the Council orientation on January 5, 2012.

Council member Carrico spoke about the bike program and thanked the program's volunteers for their efforts.
