Starbucks Coffee has built a new 480-square-foot drive-thru and walk-up facility at 200 W. 104th Street. The store is constructed with unique and innovative environmentally friendly materials. The Northglenn store is the second Starbucks location like this in the nation. The other is in Tukwila, Washington, a suburb of Seattle, and was a pilot project for this type of building. Starbucks plans on using this model for stores worldwide. The facility is manufactured in the United States using a reclaimed shipping container from China. Both the inside cabinets and flooring are constructed from recycled materials. The faucets, lighting, HVAC and food refrigeration are all environmentally-friendly. Even the spray insulation is soy based. They employ 10 people, and the hours of operation will be 10 am – 10 pm daily. In addition to Starbucks' array of beverages, they will serve light breakfast, lunch and snack items as well.

Sugar Bean Bakery, LLC leased 1,400 square feet at 2145 E. 120th Ave., Unit A. The company sells bakery goods, cookies, cakes, pastries, bagels, breads and coffee. Business Expansion Project

Gayton Dance Studio has been in business for 37 years and employs eight people. They have been located in Northglenn since May 2009 at 2145 E. 120th Avenue, Unit B. The company is expanding their facility by 935 square feet. The expansion should be complete by the end of October. The new addition will be for its new *Hip-Hop Studio* called "Robin Gayton Swagg". They have hundreds of students participating in classes weekly who range from three years old to college-aged. Their dance teams have performed at pre-show and half-times for the Ringley Brothers and Barnum and Bailey Circus, the Nuggets, Harlem Globetrotters games, and many other headliners. They will also be participating in their 6th tour performing for the Royal Caribbean Cruise liners.
