PRESENTATIONS:

Youth Summit Youth Commission members Cora Streeks, Greyson Monroe, and

Tyler Dodge reported on the Youth Summit the group recently attended. They reported the conference was attended by youth commission members from seven cities and included sessions on cyber safety, advocacy, leadership, and disaster preparedness. The members stated the Commission set goals at the conference that include creating a street art contest, a promotional/recruitment video, and a youth dodge ball tournament. The members stated the conference provided an opportunity to learn from other commissions

and thanked Council for their support.

Economic Development

Update

Ms. Debbie Tuttle, Economic Development Manager, reported on the Inaugural Business Appreciation Breakfast and thanked Council for participating in the successful event. Ms. Tuttle reported on new businesses, the Urban Renewal Plan project, and unemployment statistics. Ms. Tuttle also reported on the upcoming Count the Lights contest.
