A BILL FOR AN ORDINANCE AMENDING ARTICLE 7 OF CHAPTER 16 OF THE NORTHGLENN MUNICIPAL CODE TO REMOVE MATTRESSES, BEDSPRINGS AND BOX SPRINGS AS SPECIAL PICKUP ITEMS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTHGLENN, COLORADO, THAT:

Section 1. Section 16-7-4, subsection (a) of the Northglenn Municipal Code is amended by the addition thereto of a new sub-subsection (5) to read as follows:

Section 16-7-4. Materials Not Collected.

(a) The Director shall not collect as trash any of the following materials:

* * *

(5) Bedsprings, box springs, or mattresses.

Section 2. Section 16-7-5, of the Northglenn Municipal Code is amended by the deletion of subsection (a)(4) as follows:

Section 16-7-5. Materials Collected As Special Pickups and Recyclables.

(a) The Director shall not collect as trash any of the following materials:
