

CR-68, 2012 Street Improvements Contract

BACKGROUND

During the January 19, 2012 Study Session, staff presented the proposed 2012 Residential Street Program to City Council for discussion and endorsement. The four street segments designated for overlay are as follows:

- E. 105th Avenue from Lincoln Ct. to Grant Drive
- Claude Court from E. 120th Avenue to E. 112th Place
- Spangler Drive from Croke Drive to West End
- W. 101st Avenue from Pecos St. to Croke Dr.

On May 24, 2012, the City accepted three (3) formal bids for the 2012 Street Improvements Project. The low bid was from **Brannon Sand & Gravel, LLC** in the amount of \$436,000.00. This amount exceeds the Residential Street Budget of \$394,909.00.

BUDGET/TIME IMPLICATIONS

Staff is seeking approval of an appropriation amendment to the Capital Projects Fund to authorize the spending of **\$62,891.00** to complete the 2012 Residential Street Program. This amendment includes a 5% contingency that was not discussed in the May 24, 2012 study session. The appropriation amendment will access fund balance accumulated as a result of prior year transfers originating from the General Fund.

RECOMMENDATION

Attached to this memorandum is a Resolution that, if approved, would:

- 1) Authorize the Mayor to execute a contract between the City of Northglenn and Brannon, Sand & Gravel, LLC for the **2012 Street Improvements Project** in the amount of **\$436,000.00**, and;
- 2) Authorize \$21,800.00 (5%) as a contingency and authorize the City Manager, on behalf of the City, to approve minor changes in the scope of work and execute relevant change orders up to the approved expenditure limit of **\$457,800.00**.

Attached to this memorandum is an Ordinance that, if approved, would:

- 1) Provide an appropriation amendment of funds for the 2012 Street Improvements Project.

Staff recommends approval of the proposed Resolution and Ordinance.

A BILL FOR A SPECIAL ORDINANCE AMENDING THE 2012 BUDGET RECOGNIZING REVENUES AND APPROPRIATING EXPENDITURES BY APPROPRIATION AMENDMENT, FOR THE PAYMENT OF THE COSTS AND EXPENSES OF THE MUNICIPAL GOVERNMENT, AGENCIES AND OFFICES OF THE CITY OF NORTHGLENN, COLORADO, FOR THE FISCAL YEAR BEGINNING JANUARY 1, 2012

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTHGLENN, COLORADO, THAT THE 2012 BUDGET SHALL BE AMENDED AS FOLLOWS:

Section 1. Appropriation amendment.

- (a) Capital Projects Fund. Amend the 2012 Capital Projects Fund budget to increase appropriations in the amount of \$62,891 as follows:**

\$62,891 added to the Residential Street Program capital improvement project.

Recognize a decrease in 2012 Capital Projects Fund committed fund balance in the amount of \$62,891 represented by the above expenditure appropriations.

Section 2. The City Council of the City of Northglenn, Colorado, hereby finds and declares that in making appropriations provided by this ordinance:

- (a) No appropriation for debt service has been reduced or transferred.
- (b) No appropriation has been reduced below any amount required by law to be appropriated.
- (c) No appropriation has been reduced by more than the unencumbered balance thereof.
- (d) In the case of each transfer of all or part of any unencumbered appropriation, such transfer has been requested and approved by the City Manager.
- (e) In the case of each reduction of an appropriation, the City Manager has rendered his report and recommendations thereon and has requested and approved such reduction.
- (f) In the case of the appropriation amendment, the City Manager has certified that there are funds available for appropriation.
