A BILL FOR AN ORDINANCE AMENDING SECTION 18-14-8(c) OF THE NORTHGLENN MUNICIPAL CODE CONCERNING THE SOURCE OF MEDICAL MARIJUANA OFFERED FOR SALE AND/OR DISTRIBUTION BY LICENSED MEDICAL MARIJUANA CENTERS AND SECTION 18-14-26(c) CONCERNING REVISIONS TO THE NUMBER OF OUNCES AND PLANTS THAT MAY BE SOLD BY SUCH CENTERS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTHGLENN, COLORADO, THAT:

Section 1. Section 18-14-8, subsection (c) of Northglenn Municipal Code, "Medical Marijuana Centers," is hereby amended to read as follows:

**Section 18-14-8. Medical Marijuana Centers**

\* \* \*

(c) With the exception of medical marijuana infused products, at least ~~seventy percent (70%)~~ FIFTY PERCENT (50%) of the medical marijuana offered for sale and/or distribution must be comprised of medical marijuana grown at the medical marijuana center's own licensed optional premises cultivation facility. EFFECTIVE JULY 1, 2019, MEDICAL MARIJUANA CENTERS ARE NOT REQUIRED TO HAVE ANY PERCENTAGE OF VERTICAL INTEGRATION WITH ITS OWN LICENSED OPTIONAL PREMISES CULTIVATION FACILITY WITH RESPECT TO THE MEDICAL MARIJUANA OFFERED FOR SALE AND/OR DISTRIBUTION.

Section 2. Section 18-14-26, subsection (c) of Northglenn Municipal Code, "Prohibited Acts," is hereby amended to read as follows:

**Section 18-14-26. Prohibited Acts**

(c) sell, give, dispense or otherwise distribute to any patient or primary caregiver who is not a licensee more than two (2) ounces of any usable form of medical marijuana ~~within any seven-day period of time~~, EXCEPT THAT A CENTER MAY SELL MORE THAN TWO OUNCES TO A PATIENT OR CAREGIVER WHO HAS BEEN RECOMMENDED AN EXTENDED OUNCE COUNT BY HIS OR HER RECOMMENDING PHYSICIAN IN ACCORDANCE WITH REGULATIONS ADOPTED BY THE STATE LICENSING AUTHORITY.

Section 3. Section 18-14-26 "Prohibited Acts," is amended by the addition of a new subsection (j) to read as follows:

**Section 18-14-26. Prohibited Acts**

(j) SELL GIVE, DISPENSE OR OTHERWISE DISTRIBUTE TO ANY PATIENT MORE THAN SIX (6) IMMATURE PLANTS, EXCEPT THAT A MEDICAL MARIJUANA CENTER MAY SELL MORE THAN SIX (6) IMMATURE PLANTS, BUT MAY NOT EXCEED HALF THE RECOMMENDED PLANT COUNT, TO A PATIENT WHO HAS BEEN RECOMMENDED AN EXPANDED PLANT COUNT BY HIS OR HER RECOMMENDING PHYSICIAN IN ACCORDANCE WITH REGULATIONS ADOPTED BY THE STATE LICENSING AUTHORITY.
