## PURPOSE

To set public hearings on CB-1917 – Supplemental Appropriation and CB-1918 – Marijuana Sales Tax for the special City Council meeting on December 17, 2018.

## BACKGROUND

Section 3-1-4(d) of the Municipal Code states the following regarding the procedure for the adoption of ordinances:

"Once approved on first reading, it shall be posted in full pursuant to resolution of Council unless otherwise provided herein. Council shall hold a public hearing on the ordinance at the next regular meeting unless a different date for such hearing is set by resolution. Notice of the day, hour, and place of the public hearing shall be included in the first posting."

Due to the cancellation of the December 24, 2018 regular City Council meeting, staff has prepared resolutions setting the public hearings on CB-1917 and CB-1918 for the special City Council meeting to be held on December 17. The ordinances will also be scheduled for second reading at that meeting.

## **STAFF RECOMMENDATION**

Attached to this memorandum are resolutions which, if approved, would set the public hearings on CB-1917 and CB-1918 for December 17, 2018. Staff recommends approval of the resolutions.

#### **BUDGET/TIME IMPLICATIONS**

Conducting the public hearings on December 17 will allow Council to consider the adoption of the ordinances at the same meeting. If adopted, the ordinances will be published as required by the City Charter and Municipal Code, and will take effect prior to or on January 1, 2019.
