## **BACKGROUND**

On July 31, 2012 the City of Northglenn received bids for the replacement of two snow plows with associated hardware and hydraulics for two tandem axle dump trucks. The cabs, chassis and dump bodies are in good condition but the existing Monroe plows are in poor structural condition and frequently require significant maintenance. MacDonald Equipment Company of Commerce City was low bidder at a total cost of \$38,542.00. A copy of the Bid Summary is attached to this memorandum.

### **BUDGET/TIME IMPLICATIONS**

The Public Works Street Maintenance and Distribution/Collection Divisions have a total of \$39,648.68 remaining in the approved 2012 Capital Equipment budget for this purchase. If approved, installation of the new plows should be completed in time for use during the upcoming winter snow and ice season.

#### RECOMMENDATION

Attached to this memorandum is a Resolution that, if approved, would allow the City Manger to issue a Purchase Order to MacDonald Equipment Company in the amount of \$38,542.00.

Staff recommends approval of this resolution.
