CALL TO ORDER Mayor Downing called a regular meeting of the Northglenn City

Council to order on Monday, August 13, 2012 at 7:00 p.m. in the City Hall Council Chambers, 11701 Community Center Drive,

Northglenn.

PRESENTATIONS:

Economic Development

Update

Ms. Debbie Tuttle, Economic Development Manager, spoke about the Adams County Connects program, construction at the Auto Nation site, the Larkburger grand opening, and new businesses in the City. Ms. Tuttle announced the Northglenn Urban Renewal Authority's (NURA) annual report had been released, and reported on the status of the Urban Renewal Plan project and grants approved by the NURA Board. Ms. Tuttle provided information about business appreciation awards and noted the first annual event for the program would be held in early November.

PUBLIC INVITED TO BE HEARD

Mayor Downing called for any person wishing to address City Council on matters of community interest related to City business not set for public hearing to come forward.

Dr. Sean Reif, Ward I, spoke about public comment, the Urban Land Institute's fall conference, and pursuing leadership training and professional development.

Ms. Elaine Huslig expressed concern about safety and the decreasing quality of life in her neighborhood due to the skatepark in E.B. Rains, Jr. Memorial Park. Ms. Huslig spoke about specific incidents involving individuals at the skatepark and suspected illegal activities

in the area.

Mr. Jeff Hollman stated he owns multiple properties in the Parkview Townhomes and expressed concern about incidents related to the skatepark. Mr. Hollman stated residents are moving out of the townhomes because of the violent and illegal activities occurring at the park.

Ms. Debbie Williams stated she is a new resident of the Parkview Townhomes and spoke about two incidents that occurred near her back yard. Ms. Williams inquired about increased enforcement in the area, signage to deter illegal activities, and the possibility of installing signs to identify private property.

Ms. Jennifer Tenorio stated she lives near 118th Avenue and Huron Street and expressed concern about drag racing in the area. Ms. Tenorio stated she has asked for speed bumps to be installed in the area and stated she is concerned about children walking to school with the traffic issues.

There was discussion among Council about the skatepark and possible solutions to address the concerns of the neighborhood.

City Manager Simmons provided information on the Washington Street Pedestrian Underpass at Grange Hall Creek project and stated staff is recommending the public hearings on CB-1776, CB-1777, and CB-1778 be continued.

City Attorney Hoffmann confirmed that it is staff's recommendation to continue the public hearings to August 27, 2012.

Mayor Downing reported that Ms. Fern Hinkhouse, one of the original owners of Karl's Farm Dairy, had passed away and stated services for Ms. Hinkhouse would be held on Tuesday, August 14.

Council member Carrico congratulated the Parks and Recreation Department for receiving nominations for the best of the north end for E.B. Rains, Jr. Memorial Park, the Bill Goodspeed Happy Tails Dog Park, and the D.L. Parsons Theatre. Council member Carrico reported the North Metro Fire Rescue District had received an international medal of valor for their efforts responding to the house fire in Fox Run earlier this year. Council member Carrico reported she participated in National Night Out and invited Council to attend the Senior luncheon on Friday, August 17th.
