Update

Ms. Debbie Tuttle, Economic Development Manager, discussed current development projects, business and employment statistics, prospect activity, and Northglenn Urban Renewal Authority (NURA) approval of two Business Improvement Grant (BIG) awards. Ms. Tuttle also spoke regarding NURA approving an economic development incentive package to assist Northglenn Greens Holdings in relocating water lines in anticipation of adding a new retail building on the property, generally located at 104th Avenue and Bannock Street.

Ms. Tuttle addressed questions from Council about The Glenn Bar and Grill property improvements, Northglenn Greens waterline improvements, and changes at The Coffee Market.
