Councilwoman Carlow stated she has received six nominations for the holiday lighting program. She stated letters were sent to last year's winners to ask them to be spotters for this season.

Councilwoman Tichy reported on the holiday lighting program she attended at Boondocks Fun Center. She spoke about how the program supports the Adoption Exchange and stated she was very impressed with the program.

Councilwoman Paiz stated she had asked City Manager Nelson to obtain buy out prices for Council computers. She stated the out-going members could contact him for information on the value of the computers.

Councilman Gillespie stated there would be a Christmas sale at the Stonehocker farmhouse this Saturday and Sunday. He stated the Arts and Humanities Foundation had decorated the bridge in E.B. Rains Jr. Memorial park and the Senior Commission would be decorating the boathouse for the holiday season. Councilman Gillespie stated he would be cooking a free breakfast for the seniors in January and asked anyone interested in helping to contact him.

Sales Tax Question Water Fund

Councilman Gillespie stated Council had received information from Mr. Brent Worthington, FISS Manager, regarding two ballot questions relating to the Water Fund income. He stated a ballot question would be needed for next year's election to discontinue the annual \$260,000 fund transfer and to adjust the sales tax amounts that are deposited into the fund.

Mayor Novak suggested scheduling this item for a study session in the first quarter of 2006.

Council Liaisons on Boards Outside the City

Mayor Novak stated the Fire District Board had previously requested all municipalities to appoint a liaison to work with the board. Mayor Novak asked Council if they would be in favor of establishing liaisons for boards and commissions outside the City such as the Fire District Board, School District Board and the Rangeview Library District Board. Mayor Novak asked the Council elect members in the audience for input and they were receptive to the idea.
