A RESOLUTION REQUIRING THE INSTALLATION OF TRAFFIC CONTROL SIGNALS AT THE INTERSECTION OF $112^{\rm TH}$ AVENUE AND LARSON LANE AND ON MALLEY DRIVE BETWEEN GRANT DRIVE AND COMMUNITY CENTER DRIVE, AND APPROVING THE INSTALLATION OF INTERIM TRAFFIC CONTROL DEVICES AT BOTH LOCATIONS.

WHEREAS, the City has conducted a warrant study regarding the traffic volume and roadway conditions at the intersection of 112th Avenue and Larson Lane;

WHEREAS, the City has conducted a warrant study regarding the traffic volume and the roadway conditions at the Farmers Highline Canal crossing on Malley Drive between Grant Drive and Community Center Drive;

WHEREAS, the City has determined that the traffic conditions at the intersection of 112th Avenue and Larson Lane require the installation of a traffic control signal to regulate the flow of traffic, and in anticipation of future road widening projects at this intersection, it is appropriate to install an oversized signal at this intersection to ensure the traffic control signal will accommodate the future roadway widening projects;

WHEREAS, the City has determined that the traffic conditions and the presence of pedestrians at the Farmers Highline Canal crossing on Malley Drive between Grant Drive and Community Center Drive warrant the installation of a pedestrian cross walk signal at the location; and

WHEREAS, the City finds and determines that until permanent traffic control signals can be installed at the two aforementioned locations it is necessary to install interim traffic control devices at both locations.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTHGLENN, COLORADO, THAT:

<u>Section 1</u>. The City Council determines that a traffic control device shall be installed at the intersection of 112th Avenue and Larson Lane, and a pedestrian cross walk signal shall be installed at the Farmers Highline Canal crossing on Malley Drive between Grant Drive and Community Center Drive.
