
BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF NORTHGLENN, COLORADO, THAT:

A BILL FOR AN ORDINANCE AMENDING SECTIONS 11-35-2, 11-35-5 AND 11-35-6 OF THE NORTHGLENN MUNICIPAL CODE EXCLUDING BALLOONS FROM THE DEFINITION OF A SIGN

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTHGLENN, COLORADO, THAT:

Section 1. Section 11-35-2, subsection (u) of the Northglenn Municipal Code is amended by the addition thereto of a new sub-subsection (7) to read as follows:

- (u) Sign – An object or device or any part thereof situated outdoors or indoors which is used to advertise, identify, display, direct, or attract attention to an object, place, person, institution, organization, business, product, service, event, or location by any means, including words, letters, figures, designs, logos, fixtures, colors, motion, illumination, or projected images. Signs do not include the following:

(7) BALLOONS that are less than two (2) feet in diameter.

Section 2. Section 11-35-5, sub-subsection (a)(3)(g) of the Northglenn Municipal Code is amended to read as follows:

(3) Grand Opening Signs are temporary signs announcing the official opening of a new business, or a change in ownership or management, and are subject to the following restrictions:

* * *

(g) Balloons IN EXCESS OF TWO (2) FEET IN DIAMETER and pennants may be used in addition to temporary wall, banner and detached type signs for a period not to exceed fifteen (15) days after opening.


Section 3. Section 11-35-6, subsection (h) of the Northglenn Municipal Code is amended to read as follows:

Section 11-35-6. Prohibited Signs. The following signs shall not be erected or maintained:

* * *

(h) Balloons IN EXCESS OF TWO (2) FEET IN DIAMETER, banners, pennants, or wind-powered devices, except as allowed in Section 11-35-5(a)(3), (4) and (5).
