A BILL FOR AN ORDINANCE REPEALING AND REENACTING SECTION 5-8-15 OF THE NORTHGLENN MUNICIPAL CODE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTHGLENN, COLORADO, THAT:

Section 1. Section 5-8-15 of the Northglenn Municipal Code is hereby repealed in its entirety and reenacted to read as follows:

Section 5-8-15. Transfer of Appropriations. Except as provided in Section 5-8-16,

(a) At any time during the fiscal year the City Manager may transfer part or all of any unencumbered appropriation balance among ~~the~~ programs, WITHIN A departments, OFFICE or ~~activities~~ AGENCY for which such appropriation was made.

(b) Upon written request by the City Manager, the City Council may by ordinance transfer part or all of any unencumbered appropriation balance from one fund to another fund. Such ordinance ~~shall~~ MAY take effect immediately upon adoption.


