A BILL FOR AN ORDINANCE AMENDING THE NORTHGLENN LIQUOR LICENSING ORDINANCE BY AUTHORIZING THE CITY CLERK TO ISSUE TEMPORARY PERMITS PURSUANT TO C.R.S. § 12-47-303 AND TO ALLOW THE IMPOSITION OF A SPECIAL PRIVATE OCCASION PERMIT FEE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTHGLENN, COLORADO, THAT:

Section 1. Section 18-2-4 of the Northglenn Municipal Code is hereby amended to read as follows:

Section 18-2-4. Administrative Approval of Certain Applications.

(a) In the event that there have been no violations of the Colorado Liquor or Beer Code, as applicable, during the preceding year, and if there is no other derogatory information regarding the licensee, its partners, officers, directors, managers, or shareholders, then the City Clerk may grant the renewal of a liquor license, transfer of ownership, change of corporate status, or manager registration on behalf of the Licensing Authority. If, however, the City Clerk's investigation discloses any proved or alleged violations of the Liquor or Beer Code or derogatory information as described above, the Clerk shall schedule action on the application before the Licensing Authority.

(b) THE CITY CLERK IS FURTHER AUTHORIZED IN ACCORDANCE WITH THE PROVISIONS AND LIMITATIONS CONTAINED IN C.R.S. § 12-47-303 TO ISSUE A TEMPORARY PERMIT DURING THE TIME IN WHICH AN APPLICATION TO TRANSFER THE OWNERSHIP OF A LICENSE IS PENDING.

Section 2. Section 18-2-8.5, subsection (a)(1) of the Northglenn Municipal Code is hereby amended to read as follows:

(1) The application is filed at least 30 days prior to the date of the event, AND IS ACCOMPANIED BY AN APPLICATION FEE IN AN AMOUNT DETERMINED BY THE LICENSING AUTHORITY;
