A RESOLUTION APPROVING THE INTERGOVERNMENTAL AGREEMENT AMENDING THE JUNE 29, 1979 FOUR-WAY AGREEMENT AND TERMINATING THE FEBRUARY 11, 2002 STANDLEY LAKE DAM RENOVATION AGREEMENT BETWEEN THE CITIES OF NORTHGLENN, THORNTON AND WESTMINSTER AND THE FARMERS RESERVOIR AND IRRIGATION COMPANY

INTERGOVERNMENTAL AGREEMENT AMENDING THE JUNE 27, 1979 FOUR-WAY AGREEMENT AND TERMINATING THE FEBRUARY 11, 2002 STANDLEY LAKE DAM RENOVATION AGREEMENT

This Intergovernmental Agreement (Agreement) is made this _____ day of _____, 2006 among the City of Thornton (Thornton), a municipal corporation, the City of Westminster (Westminster), a municipal corporation, the City of Northglenn (Northglenn), a municipal corporation (collectively, the Cities), and the Farmers Reservoir and Irrigation Company (FRICO)(collectively, the Parties).

WITNESSETH

WHEREAS, the Parties have previously entered into an Agreement commonly referred to as the "Four-Way Agreement" on June 27, 1979, and which Agreement remains fully in force and effect; and

WHEREAS, the Parties have previously entered into the Standley Lake Dam Renovation Agreement (Design Services Agreement) on June 16, 1999, to design required safety improvements to Standley Lake Dam; and

WHEREAS, the Parties have previously entered into the Standley Lake Dam Renovation Intergovernmental Agreement (Construction Services Agreement) on February 11, 2002, to construct required safety improvements to Standley Lake Dam; and

WHEREAS, The Design Services Agreement and Construction Services Agreement each contemplated that the Parties would amend June 27, 1979 Four-Way Agreement once an operational new outlet works were successfully completed.

WHEREAS, the successful completion of an operational new outlet works with increased flow capacity that will satisfy the long-term needs of the Parties as contemplated in Article 1 of the Construction Contract has been achieved; and

WHEREAS, it is appropriate and necessary to set forth in a separate Intergovernmental Agreement these amendments in greater detail.

NOW, THEREFORE, in consideration of the mutual promises contained herein, the Parties agree as follows:

1. Amendment to the Four-Way Agreement.

i. The Parties hereto agree that successful completion of an operational new outlet works that provides increased flow capacity eliminating the need for priorities of use as contemplated in Article 1 of the Construction Contract now exists, the Parties hereby agree that the Four Way Agreement dated June 27, 1979, is permanently amended to eliminate the priorities of use of the Standley Lake outlet works and Paragraphs 8 and 17.g thereof are hereby deleted in their entirety.

- 2. Termination of the Standley Lake Renovation Design Services Agreement
 - i. The construction services for the Standley Lake Renovation Project have been completed. The Parties hereto agree that the February 11, 2002 Standley Lake Dam Renovation Intergovernmental Agreement (Construction Services Agreement) is hereby terminated.
- 3. <u>Charter Compliance</u>. The Cities intend this Agreement to be made in compliance with the charters of each respective City.
- 4. <u>Notices.</u> Any notice to the Parties which is required or permitted by this Agreement shall be in writing, and shall be deposited in the United States mail, postage prepaid, addressed as follows:
