A BILL FOR AN ORDINANCE AMENDING SECTION 16-7-9 OF THE NORTHGLENN MUNICIPAL CODE BY THE REPEAL AND REENACTMENT OF SUBSECTION (a)(6) AND THE ADDITION OF A NEW SUBSECTION (a)(7) REQUIRING THAT TRASH CONTAINERS BE KEPT HIDDEN FROM VIEW UNLESS AN EXEMPTION IS GRANTED WHEN SUCH CONTAINERS ARE NOT PLACED FOR COLLECTION.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTHGLENN, COLORADO, THAT:

Section 1. Section 16-7-9, subsection (a) of the Northglenn Municipal Code is hereby amended by the repeal and reenactment of subsection (a)(6) and the addition of a new subsection (a)(7) to read as follows:

(a) Trash shall be collected from an eligible residence only if:

\* \* \*

(6) TRASH CONTAINERS WHEN NOT PLACED FOR COLLECTION ARE STORED AT A RESIDENCE IN SUCH A MANNER SO AS TO BE HIDDEN FROM PUBLIC VIEW. SUBJECT TO THE PROVISIONS OF SECTION 16-7-9(a)(7), IT SHALL BE UNLAWFUL TO STORE TRASH CONTAINERS IN PUBLIC VIEW WHEN SUCH TRASH CONTAINERS ARE NOT PLACED FOR COLLECTION.

(7) The ~~Director of Maintenance and Operations~~ CITY MANAGER OR THE CITY MANAGER'S DESIGNEE shall consider any written request FOR THE FOLLOWING DEVIATIONS by an eligible residence:

A. To deviate from the required sidewalk or curblane placement of trash containers or bundles, pursuant to section 16-7-9(a)(2) without additional fee upon a showing of need and good cause; AND

B. TO DEVIATE FROM THE REQUIREMENT THAT TRASH CONTAINERS BE HIDDEN FROM PUBLIC VIEW WHEN NOT PLACED FOR COLLECTION PURSUANT TO SECTION 16-7-9(a)(6) UPON A SHOWING OF NEED AND GOOD CAUSE.
