# **New Business Announcements**

**AutoNation** purchased 6.84 acres and the 37,124-square foot former Northglenn Dodge property at 759 W. 104<sup>th</sup> Avenue. The purchase price was \$5.76 million, and will accommodate two new car and service franchises for this area. "This will be part of a multiple franchise expansion in Colorado," said Harry Brumley, AutoNation's Director of Real Estate. The company plans to invest several million dollars on property renovations and equipment, and will add approximately 100 new jobs to Northglenn's employment base. They plan to open in 3-6 months.

**Digitech Communications** leased 1,700 square feet at 1466 W. 104<sup>th</sup> Avenue. The company is a sales distributor of Cricket cellular products, and employs three people.

**Wing'n It** is a start-up company that has leased 1,230 square feet at the former Wingman property at 1450 104<sup>th</sup> Avenue. They plan to open in mid-March and will employ 5-7 people.

## **Business Expansion Projects**

**Colorado Department of Motor Vehicle** moved from its previous location in the Malley Shopping Center to 3,430 square feet at 11990 North Washington Street. They opened in the Washington Plaza on February 6th, and this expansion project retained 14 jobs in Northglenn.

**Bed Bath & Beyond** in the Northglenn Marketplace completed more than \$375,000 in tenant and property renovations. This included new HVAC, cart corrals, sign installation, window enhancements, and many other improvements.

**Boondocks Fun Center's** located at 11425 Community Center Drive brings in more than 400,000 visitors annually to Northglenn. Their \$4.5 million expansion and remodeling project will be complete in mid-March. Their grand opening is scheduled for March 16<sup>th</sup>, and they will unveil their new state-of-the art 20-lane bowling alley and corporate meeting facilities.

The Glenn Bar & Grill located at 11140 Irma Drive will be making major site improvements to their property. This will include extensive landscaping, sidewalks, curb and gutter, ADA ramps, and stairs.

Santiago's Express located at 2135 120<sup>th</sup> Avenue will be expanding into the former Coffee Market space.

## **Closed Northglenn Businesses**

Retention of our existing companies is a priority for the city. We are always disappointed when we have to report business closures and companies that have moved from our community. The following companies closed in December, but were reported during the month of January.

#### Unemployment

The table below shows estimated labor force, employment and unemployment information for December 2011. It reflects that more than 2,100<sup>+</sup> Northglenn citizens are unemployed. This is an increase of .6% over last month (9.1%).

In December 2010 Northglenn's unemployment rate was 10.3%, so we are showing a positive decline over the last year. However, Northglenn and Adams County continues to be higher than the statewide unemployment rate at 7.9%.

## **Existing Northglenn Licensed Businesses**

The following information provides a comparison of businesses licensed to do business in Northglenn at the end of January 2011. It indicates a 3.8% increase in storefront/physical locations, and an overall total (with home-based companies) increase of 5% over the past year.
