


A BILL FOR AN ORDINANCE ESTABLISHING THE MILL LEVY OF THE CITY OF NORTHGLENN, COLORADO, FOR THE FISCAL YEAR 2006, COLLECTIBLE IN 2007, FOR MUNICIPAL PURPOSES.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORTHGLENN, COLORADO, THAT:

For the fiscal year 2006, the mill levy for the City of Northglenn, State of Colorado, for municipal purposes, shall be and is hereby established at 11.597 mills.

This ordinance shall take effect, and the taxes imposed hereby, which are unchanged from the previous year, shall become effective at 12:00 a.m., January 1, 2007.
