THIS SPECIAL ORDINANCE AMENDS ORDINANCE 1427 BY REPLACING THE OFFENDING SECTION WITH THE PROPER LANGUAGE AND REPEALING THE PROPER ORDINANCE – ORDINANCE 977, SERIES OF 1989.
