## **RECOMMENDATION:**

Attached to this memorandum is a Resolution, which, if approved, would allow the installation of the 2011 People's Choice winning sculpture *Desert Mother* by James W. Paulsen at the trail-head at Fox Run directly off of Fox Run Parkway. Also attached to this memorandum is a picture of the sculpture as well as a letter from the Northglenn Arts and Humanities Foundation (NAHF) Board of Trustees that shows support for this recommendation.

## **BACKGROUND:**

Desert Mother was first chosen by a citizen's committee as one of the six sculptures to be a part of the 2011/12 Art on Parade. Visitors to E.B. Rains Jr. Memorial Park voted for *Desert Mother* as the People's Choice winner of the six Art on Parade sculptures.

Historically, the NAHF have committed to purchasing the People's Choice winner and gifting the sculpture to the City of Northglenn as an addition to its growing sculpture collection. The NAHF is pleased to purchase *Desert Mother* and gift it to the City of Northglenn.


The NAHF recommends installation of *Desert Mother* by James W. Paulsen at the trail-head at Fox Run directly off of Fox Run Parkway. This site is conducive to sculpture placement because of the vehicle and pedestrian traffic exposure. The sculpture will be installed directly to a large stone purchased by the NAHF and permanently set on a cement pad. The cement pad will be installed by the City and paid for by the NAHF.

## **BUDGET/TIME IMPLICATIONS:**

If this location is approved, plans will immediately be put into place for the installation. A plaque is being produced for the sculpture and the dedication will occur June  $26^{th}$  while the Minnesota artist is in town. All installation costs, including the stone, cement and plaque will be paid by the NAHF.

On behalf of the Northglenn Arts & Humanities Foundation (NAHF), I would like to request that the following location be presented to City Council for the permanent installation of the sculpture, *Desert Mother* by James W. Paulsen. We anticipate the installation in early June, with a likely public dedication June 26.

**Proposed location: Trail head at Fox Run just off of Fox Run Parkway (Ward 1)** The NAHF is requesting placement of *Desert Mother* at the trail head at Fox Run just off of Fox Run Parkway. It would be placed on the west side of the street at the south trailhead. The NAHF believes this location site is conducive to sculpture placement because of the high vehicle and pedestrian traffic exposure. *Desert Mother* is a medium sized bronze depiction of a coyote and her pups. The sculpture will be installed to a large stone and set on a cement pad to complement the local natural aesthetic. We feel that *Desert Mother* is perfect for the site.

Site preparation: A cement foundation will be laid to secure the sculpture and a large natural stone will be placed on the cement foundation.
