<u>Section 1</u>. Recognition of revenues and supplemental appropriation.

(a) <u>Community Development Block Grant (CDBG) Fund.</u> Amend the 2016 CDBG Fund budget to increase forecasted revenues in the amount of \$205,347 as follows:

\$205,347 to record the acceptance of CDBG grant funds for the purpose of completing the Pedestrian Mobility Project.

Recognize an increase in 2016 CDBG Fund restricted fund balance in the amount of \$205,347 represented by the above revenue recognition.

(b) <u>CDBG Fund.</u> Amend the 2016 CDBG Fund budget to increase appropriations in the amount of \$205,347 as follows:

\$205,347 to record the expenditure of CDBG grant funds for the purpose of completing the Pedestrian Mobility Project.

Recognize a decrease in 2016 CDBG Fund restricted fund balance in the amount of \$205,347 represented by the above expenditure appropriations.

(c) <u>General Fund.</u> Amend the 2016 General Fund budget to increase appropriations in the amount of \$420,000 as follows:

\$420,000 to record the expenditure of General Fund monies for the purpose of acquiring real property.

Recognize a decrease in 2016 General Fund restricted fund balance in the amount of \$420,000 represented by the above expenditure appropriations.
